Protecting Your Home From COVID-19- Anytime On Demand

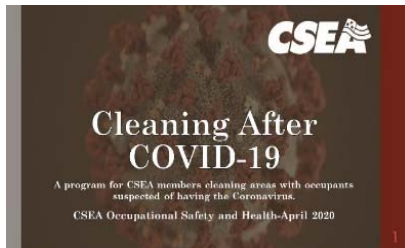

Cleaning After COVID-19 Anytime On Demand

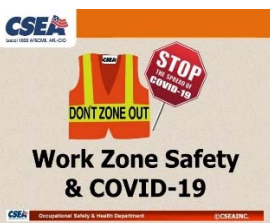

Since 1983, over 50 CSEA members have died working in roadways and even though traffic volume is decreased, fatigue, distractions and impatience of road users has increased. This 1-hour webinar will discuss essential work on roadways, best practices for social distancing, cleaning and disinfecting, personal protective equipment and a refresher of the basic principles of temporary traffic control.
