#### This month in OSH History

This September marks the 20th anniversary of the largest emergency response effort conducted in New York State history. Hundreds of CSEA members were deployed to aid in rescue, recovery and cleanup efforts at the World Trade Center following the 9/11 terrorist attacks. Many responders suffered grave consequences to their health as a result of working at the site. PTSD cases are common among responders; many of them developed respiratory illnesses, liver disease, and cancer due to exposure to toxic dust. This, in turn, highlighted the need for strong Emergency Action Plans (EAP) to ensure worker safety & health.

#### DID YOU KNOW?

First responders face unique challenges beyond exposure to hazardous working conditions. Stress from traumatic events and life-threatening situations can take an enormous toll on mental health:

- 85% of first responders have experienced symptoms related to mental health conditions.
- Depression and PTSD are up to 5 times more common in first responders than other people.

Employers must address these issues through developing and implementing EAP programs that provide employees with mental health support.
