I'm excited to announce that our **Southern Region 3 Spring Conference will be held June 9-11, 2023 at the Surfside on the Lake Resort in Lake George**. This conference will focus on union building efforts to help strengthen our union in the midst of challenges from anti-union groups. The Spring Conference will be the first of two Southern Region conferences held in 2023.
