

# 2025 Nadra Floyd Award Nomination

---

This award is named for Nadra Floyd, who served as CSEA Director of Organizing from 2000 until her untimely passing in 2001. At the time of her death, Nadra was working to grow CSEA's membership and transform the CSEA Organizing Program.



While her time at CSEA was brief, Nadra made numerous contributions to the labor and civil rights movements.

Before her union career, Nadra was active in the Black Freedom Movement, fighting for civil and human rights. During her labor movement work, Nadra demonstrated a strong commitment to fighting against injustice. She was committed to increasing the labor's movements connections to progressive social movements.

Nadra began her union career in San Diego, California. She had been a longtime activist and later served as an AFSCME Council Director. In 1997, Nadra joined the AFL-CIO's Field Mobilization Department. She later worked in the federation's Organizing Department, eventually becoming Deputy Organizing Director before joining CSEA in August 2000.

As our union's Organizing Director, Nadra brought vision, a strong sense of strategy and tactics and team approach to her job.

In the final years of her life, Nadra had faced lymphoma. While she had continued to work during her illness and had even overcome it, the illness had weakened her. She passed away on November 7, 2001.

The Nadra Floyd Award honors Nadra's legacy of strengthening the labor movement by recognizing one or more CSEA members who have made an extraordinary effort in helping organize new groups of workers into our union.
